**MALAYSIA OPERATIONS UPDATE**

The Board of OM Holdings Limited (ASX:OMH | Bursa:OMH-5298) (“**OMH**” or the “**Company**”), advises that an incident has occurred at the Company’s smelter complex in Sarawak, Malaysia (“**OM Sarawak**” or the “**Plant**”) on 17 November 2024, at approximately 1.30pm, Malaysian time.

The incident involved an overflow of molten material from casting moulds at one of the Plant’s manganese alloys workshops. On contact with water, this caused a localized blast of pressurized steam. Emergency response protocols were immediately activated, and all personnel within the affected area were safely evacuated to the designated safety zones. There were no injuries reported.

The incident was isolated and contained within half an hour. The furnace workshop sustained minimal damage, and adjacent furnaces sustained no damage. Operations are anticipated to resume with minimal disruptions, pending approvals from the relevant local authorities. OM Sarawak has initiated a detailed investigation into the incident and is cooperating with all relevant authorities.

The Company maintains its production guidance of 460,000 to 490,000 tonnes per annum for the financial year 2024. Operations at all other workshops were uninterrupted and are operating as per normal. On preliminary assessment, it is expected that there will be no material financial and/or operational impact arising from this incident.

The safety and well-being of the Company’s employees, contractors, and the surrounding community remains our top priority.
